**TERMS AND CONDITIONS**

*CamoBands, LLC*

1. Upon approval of this Application, CamoBands LLC (hereafter, "CamoBands"), in its sole discretion, and notwithstanding any request of applicant, shall have the right to terminate Applicant's credit privileges under this Application at any time without prior notice to Applicant, except as otherwise provided by law.
2. All purchases by Applicant of goods and/or services from CamoBands will be made in accordance with the terms and conditions of this Application and any distribution agreements, invoices and/or other CamoBands documents evidencing Applicant's obligations to CamoBands, all of which are incorporated herein by a franchisor or is a member of a group purchasing organization and is purchasing under an agreement (the "Master Agreement") between CamoBands and such franchisor or group purchasing organization (as applicable, the "Master Organization"). Applicant agrees to abide by all obligations and limitations imposed upon participating purchasers under the Master Agreement. Applicant further agrees that CamoBands shall not be responsible for, and Applicant hereby releases CamoBands from, all loss, damage or liability arising out of CamoBands's compliance with the Master Agreement or any directive or suggestion of the Master Organization including, without limitation, a directive or suggestion by the Master Organization requiring or suggesting that CamoBands cease further sales to Applicant pursuant to the Master Agreement.
3. The entire outstanding balance due to CamoBands on all invoices shall become due in full immediately upon default in the payment of any invoice. Applicant agrees to pay interest in the amount of 1.5% per month, or collection agency fee the highest rate permitted by law, whichever is less, on any past due amounts until collected, and Applicant agrees to pay all costs of collection incurred by CamoBands, including attorneys' fees, and expenses, should a default in payment or any other obligation of Applicant to CamoBands occur, if this account is assigned to an outside agency for collection. I/We agree to pay all attorney fees with or without suit, court costs, and a collection agency fee of 40%, which will be added to the outstanding Balance of my account. Applicant also agrees to pay a returned check fee-highest amount allowable by law for any returned items (checks or ACH's) that are dishonored for any reason.
4. **If this Application is not fully approved or if any other adverse action is taken with respect to Applicant's credit with CamoBands, Applicant has the right to request within 60 days of CamoBands's notification of such adverse action, a statement of specific reasons for such action, which statement will be provided within 30 days of said request. To obtain the statement of specific reasons, please contact our credit department.** The Federal Equal Credit Opportunity Act prohibits creditors from discrimination against credit applicants on the basis of race, color, religion, national origin, sex, marital status, or age (provided that the applicant has the capacity to enter into a binding contract); because all or part of the applicant's income derives from any public assistance pro- grams; or because the applicant has in good faith exercised any right under the Consumer Credit Protection Act. The federal agency that administers compliance with this law concerning the creditor is the Federal Trade Commission, Washington D.C

This Application and all transactions between Applicant and CamoBands shall be governed by and interpreted in accordance with the laws and decisions of the state where CamoBands's operating company which provided this Application is located, without regard to the conflicts of law provisions thereof and **all actions and proceedings arising from, relating to or in connection with this Application shall be subject to the exclusive jurisdiction of Salt Lake City/County, State of Utah.**
6. Except as to quantity of goods ordered, no terms and conditions set forth in any purchase order or other form of Applicant will apply to sales by CamoBands to Applicant.
7. Applicant may not assign any relationship with CamoBands that arises out of this Application by Applicant without the prior written consent of CamoBands which consent may be withheld for any reason. If Applicant is a corporation or other entity, a transfer or assignment of a majority of the equity interest in Applicant shall be considered an assignment within the meaning of the provision.

The approximate initial amount of credit that Applicant requires per month shall not be binding upon CamoBands, nor shall CamoBands incur liability by granting, reducing, increasing or refusing such amount. Applicant hereby certifies that the information furnished under this Application and any other financial statements furnished in connection herewith, is true and correct and this information is being furnished to CamoBands for the purpose of inducing CamoBands to extend credit to Applicant, and understands that CamoBands intends to rely upon such information. Applicant understands and agrees to be bound by the above terms and all invoices and other documents furnished by CamoBands from time to time, all of which are incorporated herein by reference, and to advise CamoBands of any material change in the information provided herein, including but not limited to, change of ownership, address or telephone number. Applicant understands that CamoBands will retain this Application whether or not it is approved. In the event applicant ceases to conduct business at the premises identified in this application or if there is any change in ownership of the applicant, including but not limited to sales of applicant's assets, stock, and agrees that applicant shall remain liable for any product delivered to the identified premises prior to receipt of said notice.
